Liability Release: I _____ as parent or legal guardian of _____ a participant (hereinafter “the participant”) hereby grant the permission necessary to allow them to participate in the above camp to be conducted by Lori Morrow. I agree to release and to hold harmless Lori Morrow, the hosting site, hotel, etc on whose premises the Camp will occur the affiliates of them and their respective employees, representatives, members, and officers from any and all liability for negligence or any other claim judgment, loss, liability, cost and expenses (including, without limitations, attorney’s fees and costs) arising out of or connected with the Camp, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that the participant may incur or sustain during the camp, all activities associated with the camp and while traveling to and from the site of the camp whether or not the camp actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees’ heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by the participant or by any other persons on the account of damages of any character resulting to the participant in any way from the foregoing activities. I further agree to reimburse and make good to Releasees any loss, or costs Releasees may have to pay as a result of any such action, claim, or demand.

I in my own behalf and on behalf of the participant, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents. I in my own behalf and on behalf of the participant am aware that this Liability Release releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumption of the risk of injury or illness. I in my own behalf and on behalf of the participant further acknowledge that nothing in this Liability Release constitutes a guarantee that the Camp will occur. I, in my own behalf and on the behalf of the participant have signed this document voluntarily and of my own free will.

Medical Release: I in my own behalf and on behalf of the participant acknowledge and agree that such participation subjects have the possibility of becoming physically ill or injured and that I in my own behalf and on behalf of the participant acknowledge that the participant is assuming the risk of such illness or injury by participating in the camp. In the event of such illness or injury, I authorize Lori Morrow to obtain necessary medical treatment of the minor and hereby, in my own behalf and on behalf of the Minor, release and hold harmless Releasees in the exercises of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of the participant for any illness or injury that the minor may sustain during the Camp and while traveling to and from the site for the Camp whether or not the Camp actually occurs.

- 10.) We encourage campers not to fraternize with other groups at their hotel or facility.
